The Convener read out the minutes of the previous meeting dated 24/01/2015 and it was approved by all the members of Student Redressal Committee.

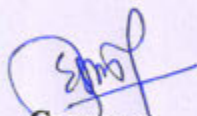
Resolution No.2

It was decided by the members that the Student Redressal Committee would take care of the Redressal of genuine complaints of students for entire session and they would be forwarded to responsible cell/committee.

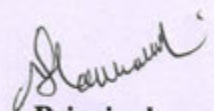

4. Demand for the enough furniture in B. A.-I Classroom.

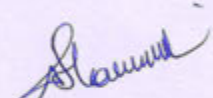
Action taken: Issue addressed to LMC and Purchase New furniture for B. A.-I Classroom.
