It was decided by the members that the Student Redressal Committee would take care of the Redressal of genuine complaints of students for entire session and they would be forwarded to concern cell/committee.

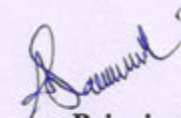

Action taken: Instructed peons to clean Water cooler regularly.

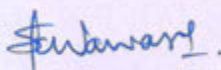
2. Complaint about non-working of tube-lights in B.Sc-III.classroom.

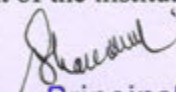

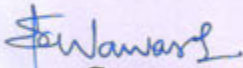
